### 4. Annual Survey Results

- Key highlights 75 responses
- 39% report a decrease in foot traffic, but data from CUI about footfalls shows that foot traffic has increased.
- Top concerns, safety, vacant spaces being filled, parking concerns
- 9% of respondents received a grant last year
- A strong awareness of beautification and cleanliness
- 25% of respondents contacted us for support and felt supported
- Large majority of respondents did not attend any of our events from last vear.
- Feel lack of respondents is less survey



- Takeaway is we need better outreach to our members look at strategies on how to engage better with our members
  - Could roll into a communication plan to see how to increase engagement - maybe something like a pulse of about 5 questions on specific topics, with . On topics that we are able to deal with.
- Insider went out about every two weeks was open April to early July.
- Raise concerns to City Hall Council through advocacy reach out to City staff to see what topics would be good to help get the word to Council.
  - Reach out to other BIA's to see what is working for them and what is not working for community engagement and marketing outreach.
  - For next board meeting staff to have some ideas ready to present.

### 6. City Updates

- About 2000 responses for the Downtown Plan so far.
- A lot of interest in office to residential conversion
  - Have added over \$3 million to that pot so far.
- Stabbing downtown negative press was incorrect on this topic. Worried about reporting and using language to grab attention and possibly make downtown be reflected negatively.

### 7. Good News Happenings

- Lots of great weekend festivals. Brings crowds and good vibes.
- Good cross promotion from Tourism London regarding festivals
- Huge numbers Sunfest had over 200,000 people walk through. This is more foot traffic in the core.
- Rides on Richmond footage of the amount of people on streets for this showed lots of attendance and enjoying - over 500 cars, over 5000 people attended.
- Museum London had 54% increase in visitors for Canada Day
